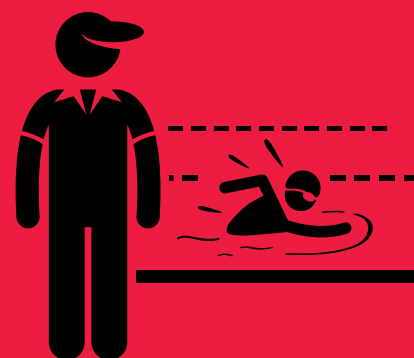

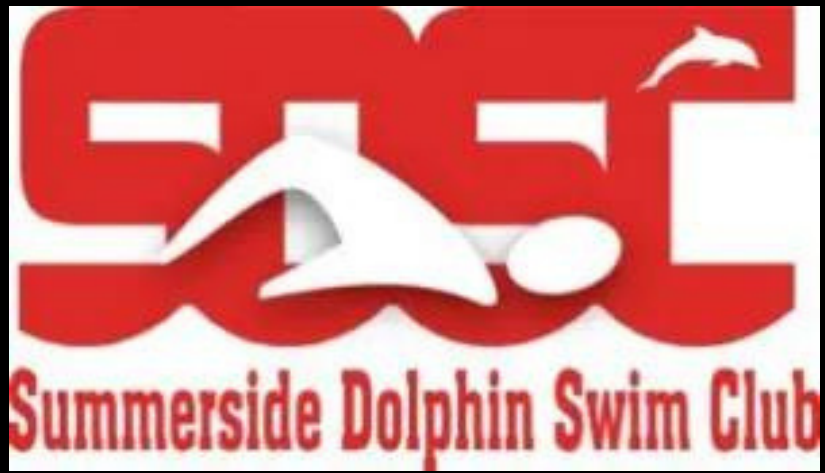

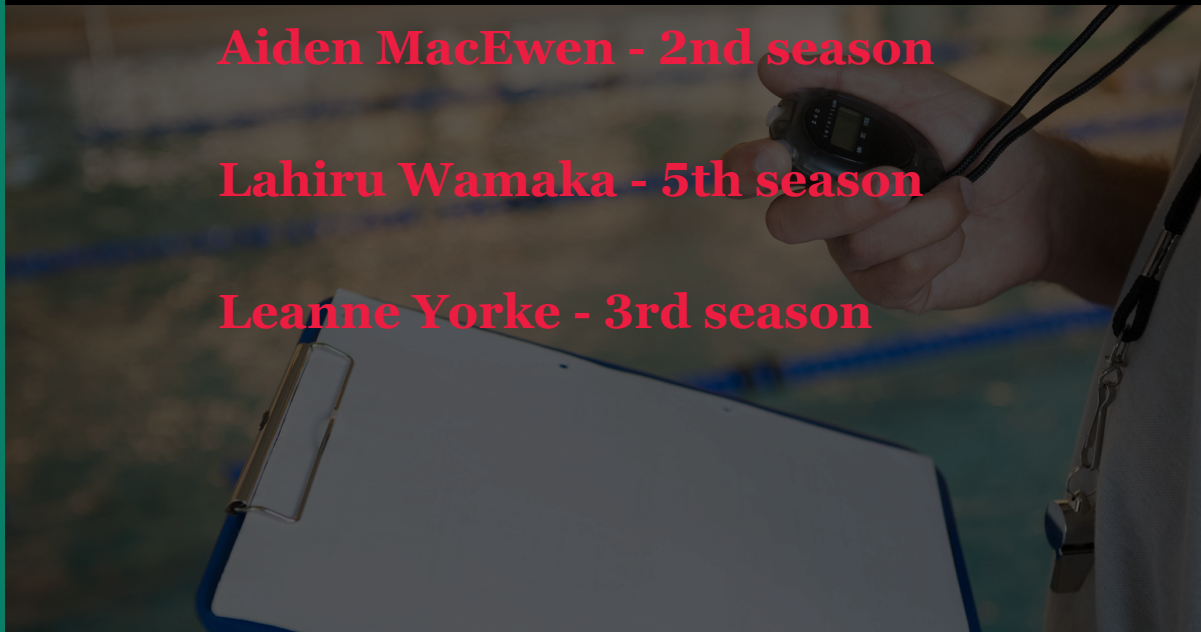

REMS UPDATE FROM SWIM CANADA

We wanted to provide you with an important update regarding the launch of REMS features, including Meet Sanctioning, Meet Entries, Meet Entry Validation, and Officials Deck Logs. After careful consideration and in partnership with the PSOs during our meetings in Calgary September 25-27, we have made the decision to postpone the launch of these features until January 2025.

This decision was made based on the valuable feedback we received from the PSOs, who have been actively listening to their users. It became clear that more time is needed to ensure a smooth

transition to the registration features of the new system before launching new modules. We recognize this announcement comes shortly after we communicated a one-month delay, from September 17 to October 17, but upon further reflection and discussion, we collectively agreed that a longer time period is necessary to provide the right level of support and preparation.

This postponement will allow us to:

Host additional training sessions: We will use this extra time to host more in-depth training sessions, ensuring PSOs are fully prepared to navigate the new system when it goes live.

Finalize tutorial videos: We are working on clear and concise tutorial videos for both the registration and meet processes, which will be available on the REMS Knowledge Base in the coming weeks.

Test meet management functionality: Based on feedback, there is a strong desire to test the meet management functionality ahead of the official launch—something we were unable to do during the summer pilot. This will give us the opportunity to identify and resolve any issues before the full rollout.

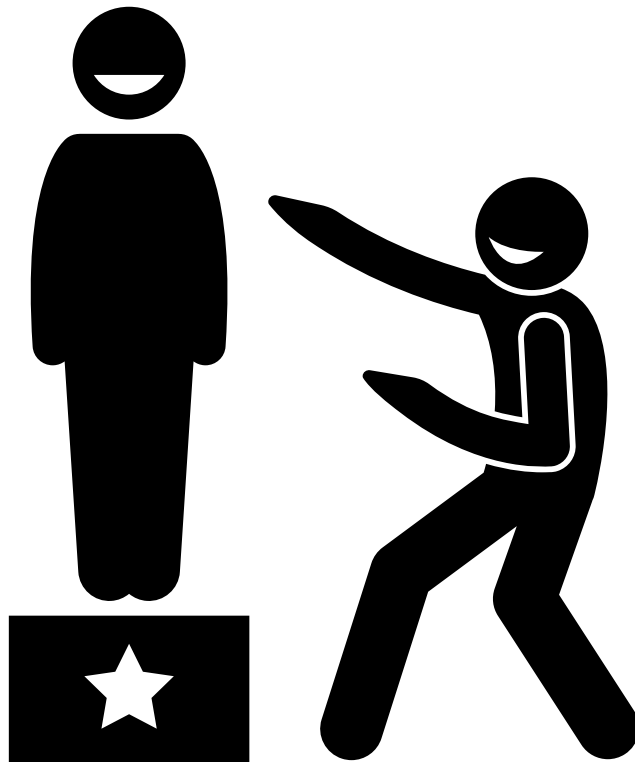
